

# NOTICE OF RACE

## 2025 A-CLASS EUROPEAN CHAMPIONSHIP

Riccione, Italy  
June 5th to 13th, 2025

**The Organizing Authority** is: the 151 RICCIONE in conjunction with the International A-Division Catamaran Association and the Italian A-Class Catamaran under the Authority of the Italian Sailing Federation (FIV) together with WORLD SAILING

This Notice of Race (NOR) is dated December 2024

<b>NP</b>	Denotes a rule that shall not be grounds for protests by a boat. This changes RRS 60.1(a).
<b>DP</b>	Denotes a rule for which the penalty is at the discretion of the International Jury.
<b>SP</b>	Denotes a rule for which a standard penalty may be applied by the race committee without a hearing or a discretionary penalty applied by the International Jury with a hearing.

## 1. RULES

- 1.1 This regatta shall be governed by the rules as defined in The Racing Rules of Sailing (RRS).
- 1.2 The International A-Class Catamaran World Championship Rules of the International A-Division Catamaran Association (IACA) shall apply to the European Championships.
- 1.3 RRS Appendix T (Arbitration) will apply.
- 1.4 RRS 40 is modified as followed: each competitor shall wear a personal flotation device except briefly while changing or adjusting clothing or personal equipment. Wet suits and dry suits are not personal flotation devices.
- 1.5 Wearing a safety helmet is mandatory for the Open discipline. It is strongly recommended for the Classic Discipline

## 2. SAILING INSTRUCTIONS

- 2.1 The sailing instructions will be available on the online official notice board no later than at 18:00 the day before the first registration day.

## 3. COMMUNICATION

- 3.1 The official notice board will be at the Racing Rule Of Sailing: <https://www.racingrulesofsailing.org/events/9427>
- 3.2 [DP] [NP] Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

## 4. ELIGIBILITY AND ENTRY

In accordance with RRS76.1, the organizers will reject or cancel the entry of any competitor of Russian or Belarusian nationality or displaying these nationalities and the participation of any boats whose owner or manager is a Russian or Belarusian individual or entity. The organizing authority may amend this rule following any further World Sailing decisions on the situation with Russia & Belarus.

- 4.1 Boats may compete in either the Open or the Classic discipline.

- 4.2 All competitors shall be fully paid-up members of the International A Class Catamaran Association, either through their respective country association membership or individual membership.
- 4.3 Competitors shall comply with World Sailing Eligibility Code, Regulation 19.
- 4.4 Entries shall be received by the Organizing Authority no later than May 4th, 2025. Requests to register after the online registration is closed are subject to approval by the Organizing Authority.
- 4.5 A Parent/Guardian Consent and Supervision Form must be completed and signed by the parent or guardian of any competitor under the age of 18. It must be filled, signed, and uploaded by the registration. Minor competitors not fulfilling this requirement may be rejected at the registration.
- 4.6 Requests for refunds will be accepted prior to May 11th, 2025, with a 60,00 Euro processing fee.

## 5. FEES

European Championship entry fees:

- Normal entry fee: Euro 300,00 valid until April 13th, 2025
- Late entry fee: Euro 450,00 valid until May 4th, 2025
- The deadline for all entries is May 4th, 2025

To be considered registered for the event, a boat must satisfy everything required for registration and pay the registration fee by bank transfer or other system to the current account in the name of RICCIONE 151 H2O SPORTS ASD CLASSE A - at the Cerry Bank, IBAN: IT70E0336524100000001000017

- Receipt of the registration fee;
- TPL insurance with minimum coverage (€ 1.500.000) as FIV Regulations for National Sports Activities Organized in Italy 2025 (Only for Italian Competitors the insurance policy can be replaced by the FIV Plus card valid for the current year) as required by international A-Class rules 15.1
- Measurement certificates (hull, mast, sail)
- License for advertising (if applicable);
- Athlete assignment form, in the case of a minor athlete (Attachment C);
- Support people accreditation form. (Attachment D)

## 6. ADVERTISING [DP]

- 6.1 Competitor advertising shall comply with World Sailing Advertising Code. (Regulation 20)
- 6.2 Boats may be required to display advertising chosen and supplied by the Organizing Authority.

- 7.3 A total of 12 races are scheduled for Open and Classic discipline.
- 7.4 3 races for each discipline may be sailed per day.
- 7.5 On the last day of the regatta no warning signal will be made after 16:00.

## 8. EQUIPMENT INSPECTION

- 8.1 Equipment inspection will be conducted in accordance with the A-Class Catamaran Equipment Inspection Regulations. Sails, boats, and equipment must be measured before arriving at the Championship.
- 8.2 All competitors at registration must produce valid and current measurement certificates for the hull, mast, and sail as A-CAT international class rules A.11
- 8.3 [DP] All boats must be kept at the regatta site commencing at the time of registration and continuing until the end of the event. Removal of any boat from the regatta site during the event shall require prior written permission from the equipment inspector.
- 8.4 A boat or equipment may be inspected at any time for compliance with the Class Rules, Equipment Inspection Regulations and Sailing Instructions. On the water a boat may be instructed by the equipment inspector to proceed immediately to a designated area for inspection.
- 8.5 Equipment shall only be replaced with permission of the Championship Technical Committee appointed to the event by the organizing authority under RRS89.2(c).
- 8.6 The Equipment Inspection Regulations for the Championship will be published on the event website no later than April 1st , 2025.

## 9. FORMAT OF RACING

- 9.1 The event consists of a single qualifying series, however if there are more than 100 boats in a discipline, fleet splitting will be used, refer Championship Rules, appendix 2. If the event consists of split fleets, fleets will be in groups of approximately equal numbers of boats ( $\pm 1$  boat).

## 10. VENUE

- 10.1 151 RICCIONE H2O Sport, Manfroni Street, 151 Zone [151riccione.com](http://151riccione.com), NOR Attachment INFORMATIONS ED UTILITIES
- 10.2 The Boat Storage will be located at the venue of 151 Riccione, NOR attachment A.

## 11. RACING AREAS

11.1 NOR Attachment B "Areas" shows the racing areas of the Regatta

## 12. THE COURSES

12.1 The courses to be sailed will be Windward/Leeward courses as detailed in the Sailing Instructions, in accordance with IACA Championship Rules.

12.2 The distance from start to Mark 1 will be at the discretion of the Principal Race Officer.

12.3 Each discipline, Open and Classic, will race on separate course areas.

## 13. PENALTY SYSTEM

13.1 RRS 44.1 is changed so that the two-turns penalty is replaced by a one-turn penalty.

## 14. SCORING

14.1 The Low Points Scoring System of RRS Appendix A will apply.

14.2 Five (5) races are required to be completed to constitute the World Championship for each Discipline.

14.3 When 5 or more races have been completed, a competitor may discard their worst score; when 9 or more races have been completed, a competitor may discard their 2 worst scores.

## 15. SUPPORT BOATS [DP]

15.1 Support boats shall register with the Organizing Authority and will be required to comply with all local safety regulations and the Event Support Boat Regulations. Support boats must show their country code as per Championship Rule

15.2 Team support boats shall complete on-site registration at the venue and pay 100,00 € for the registration. By registration, team support boats will receive the OA Flag and ID flag number. If called upon, support boats will be required to act as rescue boats.

- 15.3 [DP] [NP] When afloat, all persons on board of a support vessel shall wear a personal flotation device (PFD) and, as soon as their engine is running, drivers shall be connected with a kill-cord to their engine contact.

## 16. INTERNATIONAL JURY

- 16.1 An International Jury will be appointed for the European Championship in accordance with RRS 91(b). Its' decisions will be final as provided in RRS 70.5.

## 17. PRIZES

- 17.1 Prizes for the European Championship will be awarded for the first 5 places overall in both the Open and Classic Discipline fleets.
- 17.2 The winner of each Discipline will be awarded the title “2025 European Champion” and will receive the perpetual trophy.
- 17.3 The following prizes will also be awarded in each Discipline:
- Junior Champion (under 25 years)
  - Woman Champion
  - Master Champion (ages 45 – 50)
  - Grand Master Champion (ages 51 – 55)
  - Great Grand Master Champion (56 years and over)
  - Other prizes may be awarded at the discretion of the Organizing Authority.
- 17.4 Age determinations are based as of 12:01 am, June Sun. 8th, 2025 of practice races

## 18. RADIO COMMUNICATION

18.1 [DP] Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data transmissions that are not available to all boats. This restriction also applies to mobile phones.

18.2 Communications to the competitors will be done by electronic means (e-mails – electronic notice board). Competitors shall provide themselves with a device (smartphone, notepad, computer) to obtain and read these communications. The e-mail address inserted during the entry process shall be valid and active during the whole duration of the championship. Any difficulty in receiving communications will

not be eligible for redress. This changes RRS 62.1(a). [NP] No printed documents will be supplied.

## 19. INSURANCE

19.1 Each participating boat shall have valid, third-party liability insurance with a minimum of at least 1,5 Mil. Euro (or equivalent) per incident.

## 20. [NP] DATA PROTECTION

The European Regulation will be applied.

20.1 All participants acknowledge that there may be film or photo shootage about the regatta, sailing in and out of the harbour, programs on water and ashore that may include scenes with the participants being visible.

20.2 The organizers shall not be limited in any way to use, publish, copy, sell or give to third parties these films and photos – as far as they do not infringe personal rights.

20.3 By registering for the regatta, the entrants and participants do explicitly renounce on any relating demands, damage or compensation claims.

20.4 All participants acknowledge that the organizer is using their personal date according to the terms of the European regulations, known as GDPR. Detailed regulations will be displayed on the event website [https://151riccione.com/regate/european\\_a-cat](https://151riccione.com/regate/european_a-cat).

## 21. RISK STATEMENT

21.1 RRS 3 states: “The responsibility for a boat’s decision to participate in a race or to continue racing is hers alone”. By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

21.2 By signing an entry form, each competitor agrees and acknowledges the following:



- a) That they are participating in this regatta at their own risk.
- b) That the Organizing Authority, all sponsors, all race committee members, and volunteers, all officers, and directors of 151 RICCIONE, the IACA, and the Italian A-Cat association are not responsible for any damages, injuries or death which may result in conjunction with this regatta, onshore or afloat
- c) That they will put safety of themselves and other competitors above race results.
- d) That they will accept responsibility for any injury, damage, or loss to the extent it is caused by their own actions or omissions; and,
- e) Ensure their boat is in good order, equipped to sail in this regatta, and that they are physically fit to participate.

## 22. MEDIA CONSENT

- 22.1 By signing an Entry Form, all competitors agree to and grant the Organizing Authority, the IACA, the Italian A-Cat Association, and their sponsors, the right in perpetuity to photograph and/or videotape participation in the regatta, or at the regatta facilities, and to the use of their name, likeness, and images, without compensation and without the competitor's prior approval.

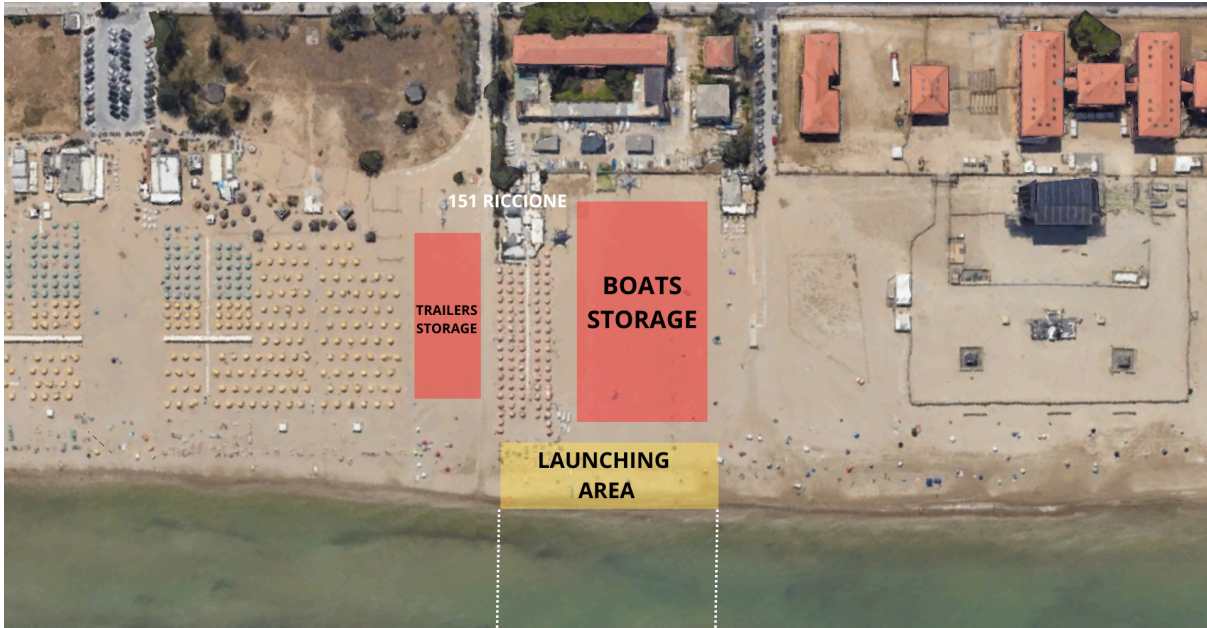
